NORWAY - Charles "Chuck" David Erickson, 66, of W5716 Warner Lane in Norway, passed away unexpectedly on Wednesday, March 18, 2009, at his home.

He was born on Nov. 30, 1942, in Iron Mountain, son of the late E.O. "Buck" and Muriel (Johnson) Erickson. He graduated from Iron Mountain High School in 1960, and then pursued his childhood dream of maintaining the heavy equipment machinery used to build roads. After attending an intensive diesel mechanics program in Illinois, Chuck was employed by Bacco Construction Co. in late 1960 starting as a field mechanic. In 1970, he became the shop superintendent, a position he held until his retirement in 1995.

From 1984-2002, Chuck also served on Bacco's Board of Directors as a stockholder. After his retirement, Chuck became a certified heavy equipment appraiser, operating this business often with the assistance of his son, Chuck.

He served in the Michigan Army National Guard beginning in September of 1964 and was honorably discharged as a sergeant in September 1970.

He married the former Karen Moe on Aug. 6, 1966, in Minneapolis, Minn. She preceded him in death on Aug. 18, 2007.

On Nov. 29, 2008, Chuck married Peggy Schram at St. Mary Queen of Peace Church in Kingsford. Together they fulfilled his dream of building a home at "the camp" complete with a beautiful den where he meticulously catalogued his extensive library of World War II books and movies.

The citizens of Dickinson County, as well as communities statewide, also benefited from Chuck's knowledge and expertise in road maintenance and building. In 1977, he began his tenure on the Dickinson County Road Commission and, since then, served as chairman various times and was currently chairman at the time of his death.

Chuck was also appointed to the County Road Association of Michigan (CRAM) Board in September 1994. There he held the offices of vice-president and president as well as serving on the following committees: General Policy Committee, Executive Committee, Commissioners' Committee, Legislative Review Committee, and the Township Relations Committee.

As a member of the U.P. Road Builders' Association, he also served as president, vice-president and secretary/treasurer.

Chuck was one of the longest seated commissioners in the state of Michigan serving the citizens of Dickinson County and Road Commissions across the state for more than 32 years.

Chuck was truly a remarkable individual, a wonderful husband, father, brother, uncle, friend and dedicated public servant. Stories of his wit, intelligence, work ethic, compassion, generosity and love are legend. His presence will be forever felt in the hearts of those who loved him. His chair at Saturday lunch and Sunday coffee may be empty, but his friends will certainly celebrate his life there and elsewhere.

Chuck is survived by his loving wife, Peggy; his son, Chuck (E-Ben) Erickson of Appleton, Wis.; his sister and brother-in-law, Kristine and Stephen Leonard of Iron Mountain; his niece, Erika (Jim) Harbridge and their children, Ava and Max of Thornton, Colo., Gabe (Jeannie) Leonard and their son, Jackson of Chicago, Zachary (Jill) Leonard and their sons, Zachary and Winston Charles of Auburn Hills, Mich.; his mother-in-law and father-in-law, Jim and Barb Schram of Iron River; his sisters and brothers-in-law, Debbie and Bob Han of Iron River, Kathy and Dave Ridolphi of Iron River, Jim and Ginny Schram of Green Bay, Wis., Richard and Jessica Schram and their families, Ann and Tilman O. Moe II of Neenah, Wis. and Gail and Leroy Neal of LaMirada, Calif. and their families.

Visitation will be Saturday from 10 a.m. to 2 p.m. (Central time) at Our Saviour's Lutheran Church in Iron Mountain.

Funeral services will follow at 2 p.m. at the church. Rev. Lori Liverance will officiate.

Burial will be in Cemetery Park.

“ Erickson family: I am very sorry to hear about Chuck. We were classmates @ IMHS. He was a fun guy to be with and have fond memories of our time together. I must report one hesterical incident:

In High School, Chuck owned a 1949 green Chevy convertible with an in-line six and split manifold (4/2), dual exhaust, standard transmission. When Chuck would rev the engine to a certain rpm range in 2nd gear, the sound resonated perfectly through his dual exhaust system and the noise coming out was absolutely deafining. Now Chuck was in a muffler ticket contest (for noise) with another classmate (not sure but of his name but I think his initials were Mike B.). MB had just gotten a muffler ticket and was now one ahead of Chuck (the number 16 seems to stand out). Chuck had a competitive streak in him and invited me to take a ride with him. With the top down on his Chevy, we headed North out of town towards the Michigan State Police Post to make some noise and get a muffler ticket. As we approcked the Mich Stae Police Post, Chuck proceded to place his '49 Chevy into second gear and I could literally hear the deafining noise bounce off the State Police Post building. Chuck proceeded past the State Police Post and then did a U-turn (legal-I'm sure) and now was heading Southbound again towards the Michigan State Police Post. Being in the Southbound lane he was even closer this time to the Post building. He again proceeded to place the Chevy into that resonant 2nd gear and again the noise was overwhelming. Chuck continued driving a little further South then performed another U-turn and headed back North again to repeat the whole process. The Troppers inside the Post got the message for as we passed by, there was a shiny blue Plymouth Mich State Police car and driver with yellow emblem on door, parked in driveway waiting and starring at Chuck. Chuck saw him and immediately pulled over (not even waiting to be pulled over) to the side of the road and the Mich State Police car pulled in behind him. The Tropper got out of his car and approached Chuck with a Gustapo type walk and confused look. Chuck was smiling all the while the Tropper wrote him the muffler ticket and Chuck threw it in the glove box with all the other tickets. Mission accomplished, he

was now tied with MB! I don't recall ever seeing anyone so determined and happy to receive a ticket!
