Gregory Wayne Diamond, 48, of Iron Mountain, died Wednesday March 2, 2011, in Show Low, Arizona, while on a business trip.

Greg was born in Seattle, Washington, on January 23, 1963, the son of G. Warren and R. Elaine (Mikkelsen) Diamond. He graduated from Lindbergh High School in Renton, Washington, in 1981, and from the University of Washington in 1986 with a Bachelor of Science degree in Pulp and Paper Science and Technology. After graduation, Greg began his 25-year career in the paper industry. He relocated to Vancouver, Washington, to work for James River Paper Company. Greg began working for Champion Paper Company in Quinnesec, Michigan in 1989. In 1995, Greg began working for Albany International. At the time of his death, Greg was Product Manager-Publication Grades for US Dryer Fabrics for Albany International.

While working in Vancouver, he met Beverly Proffitt. They married in Gresham, Oregon, on February 23, 1991. Together, they moved to the Upper Peninsula of Michigan and built a wonderful life together. Their son Drew was born May 2, 1995. Their daughter Demi was born May 9, 1997. As an Eagle Scout, Greg enjoyed being involved in scouting with Drew. He also loved the time he spent working with Drew in the garage. Greg cherished his time with Demi, his "Little Bear," as well. He was so proud of Demi's academic achievements, creativity, and outstanding athletic abilities. Greg was a

devoted and loving husband to Bev.

Greg is survived by his wife, Beverly, son Drew, and daughter Demi, all of Iron Mountain, Michigan. Greg is also survived by his mother R. Elaine Diamond of Renton, Washington; sister Kathleen Diamond Jensen, niece Kelsay Jensen and nephews Luke and Mark Jensen of Great Falls, Montana; mother-in-law and father-in-law Mary and Ken Proffitt of Gresham, Oregon; his sisters-in-law Barbara (Garry) Lewis and nephew Devin and niece Jennifer Lewis of Gresham, Oregon; Brenda (Dave) Caseday, nephew Brandon, nieces Breana and Kaitlyn Caseday of Damascus, Oregon; Becky (Frank) Hubbard of Gresham, Oregon; and his uncle, aunts, and cousins. Greg also leaves his cherished friends, who have become much like family over the last twenty years. Greg was preceded in death by his father G. Warren Diamond.

Greg had many hobbies, including anything involving motor sports. The standing competition amongst his "hot rod" buddies was who had the highest cylinder count. Greg was certainly a top finisher with a total of 83 cylinders. Greg was full of life, love, humor and wit. He had an infectious laugh and a smile that lit up the room. Greg was also determined; nothing could stand in his way. He expected the best, without exception, from himself and anyone in his circle of family, friends, and associates.
