



## John Pancheri

August 8, 1923 - August 8, 2008

IRON MOUNTAIN - John F. Pancheri, 85, of 1400 W. "A" St., Iron Mountain, died Friday, Aug. 8, 2008, at the Dickinson County Memorial Hospital.

He was born April 26, 1923, in Iron Mountain, son of the late Serafino and Santina (Feira) Pancheri. John served in the Civilian Conservation Corps at the Escanaba River in Gwinn as a truck driver. He served as a platoon sergeant in the U. S. Army Infantry from 1943 to 1946. He received the American Theater Ribbon, Good Conduct Medal, Asiatic Pacific Ribbon, and WWII Victory Ribbon. He also served in the National Guard as a motor sergeant from 1949-1951.

John married Shirley Bouffiou on Feb. 7, 1948. In 1951, he returned to high school and graduated with the class of 1952. John worked for Montgomery Ward for 25 years. He then worked as custodian at the Iron Mountain High School for 11 years and for 10 years as custodian of the Dickinson Area Catholic School, retiring in 2000.

John was a 4th Degree member Knights of Columbus and served as Grand Knight. He was a member of St. Mary & St. Joseph Church and the U.C.T. He also enjoyed playing bocce and was active in the Dickinson Area Bocce Association.

John is survived by his wife, Shirley; six children, Jack (Julie) Pancheri, Steve (Anna Fox) Pancheri, Barbara (Dennis) Bailey, Scott (Brenda) Pancheri, and Jenny (Jeff) Crosson, all of Iron Mountain, and Roberta (Robert) LaFave of Escanaba; 19 grandchildren, Jamie (Bridget) Pancheri, Matt (Jessica) Pancheri, Brooke Pancheri, Daymon Pancheri, Melissa (Scott) Rutter, Marcine Bailey, Brendan Pancheri, Brittany Pancheri, Sarah Snowdon, Jon Qualley, C.J.
